

Under authority vested exclusively in the court by Section 479.050, Missouri Revised Statutes, 1996, and by Rule 37.49, Missouri Rules of Court, 2004, it is hereby ordered that the following schedule of fines and court costs for the Violations Bureau is established. This schedule shall supersede all previous schedules of fines and costs whether established by ordinance or otherwise, and shall be applicable only to those violations disposed of prior to the scheduled court appearance noted on the summons.

It is further ordered as required by Rule 37.49, that this schedule be prominently posted at the place where fines are to be paid. Payment of scheduled fine and costs shall constitute a plea of guilty and waiver of trial. Court costs for each moving violation shall be as follows:

\$12.00 Court cost, \$7.50 Crime Victim Compensation fund, \$2.00 Biometric Verification System, \$2.00 City Police Training fund and \$1.00 State Peace Officer Training fund, \$2.00 Domestic Violence fund

Any violation not listed in this schedule requires an appearance in court unless otherwise ordered.
