I (the Responsible Party) agree to indemnify and save harmless, including all costs and attorney's fees, the City of Warrenton from any claim or loss sustained by reason of use and or participation in activities within the pavilion or City parks, and hereby assume the risk and thereby release the City of Warrenton, its employees, representatives, agents, and citizens from any claim, damage, or loss by reason of any accident, injury, or damage to myself or any person or property belonging to my group, which might occur during the course of use or participation in activities in the parks.
