P.L.A.Y. Scholarship Program 2022-2023

What is it?

The P.L.A.Y. (Providing Leisure Activities for Youth) Scholarship Program is designed for children living within the City limits of Warrenton who are experiencing financial difficulty or who are in a unique, hardship situation. The goal of the program is to provide youth access to the recreation and leisure activities of their choice, regardless of the ability of their family to pay.

Who Qualifies?

Children who reside within the City limits and qualify through the established guidelines of the reduced or free lunch program utilized by the Warrenton School District are eligible to apply. Children ages 17 and under are eligible to receive two program scholarships per year. City organized eligible programs include: Soccer, Softball, Baseball, T-Ball and Group Swim Lesson fees. Pool passes are exempt from the program.

How can I apply?

Eligible participants may only register for one program at a time. Each family only needs to complete the application one time with the information for all children who may be eligible. Applications must only be submitted once time per calendar year. Priority is granted based upon program restrictions deadlines and the funds are reserved until most current program deadlines have passed. Once every eligible child has registered for current programs, new programs will be opened for scholarship applicants. Scholarships are used until they are exhausted and may not be available at all times. At the time of application you must submit the required documentation which includes: proof of residency through voter registration card, city water bill, property tax statement, or rental agreement. A W-2 or any other documentation which shows the current hardship situation or proof of free or reduced lunch program through the Warren County School District is also required.

How is the P.L.A.Y. Scholarship funded?

This program is funded through a gift program established by the City of Warrenton. Funding sources include personal and commercial donations and/or fundraising. Donations may be made to the program following the rules and regulations established by the City of Warrenton. No taxpayer dollars are used to fund this program.
